Kendall Whittier Mercado is an open-air market featuring art, handmade goods, crafts and fresh produce.

HOURS / SETUP

SEASON: First & third Saturday of the month, May - October. **HOURS OF OPERATION:** 10:00am until 2:00pm.



LOCATION: In the parking lot on the southeast corner of Admiral Boulevard & Lewis Avenue. SET-UP: Vendors will be allowed to start setting up at 8:00am. Vendors must have their vehicles moved to designated parking no later than 9:45am for the safety of our patrons. Late set-up will not be allowed. TEAR-DOWN: Vendors are expected to have cleaned up their booth area and left the premises by 3:00pm so the parking lot can be re-opened.

MERCADO RULES

ALLOWABLE ITEMS: Art, jewelry, handmade goods, new handcrafted clothing, crafts, fresh fruits and vegetables. Special consideration will be given to items made or grown in Oklahoma.

PROHIBITED ITEMS: Include, but are not limited to, electronics, tools, furnishings, live animals, and any used or pre-owned goods. The prohibition of any goods is at the sole discretion of Kendall Whittier Main Street.

NONPROFITS/EDUCATIONAL BOOTHS: Not-for-profit organizations and booths for the purpose of community education and outreach on issues will be strictly limited to one booth per week. Sales, fundraising and/or donation solicitations are not permitted. Acceptance is at the discretion of Kendall Whittier Main Street and is limited to a maximum once-a-month basis per nonprofit organization.

FLIERS/SIGNS: Only fliers and signs related to goods displayed and sold at Mercado are allowed. No political fliers or signs can be handed out or displayed.

LAWS: Vendors are responsible for abiding by all applicable city, county, state and federal laws/regulations. **SALES TAX PERMIT:** Vendors are required to submit a copy of their sales tax permit with their application, or agree to remit sales tax on items sold to Kendall Whittier Main Street at the end of the Mercado day for payment to the Oklahoma Tax Commission.

Contact the Oklahoma Tax Commission to obtain an application for a sales tax identification number. Vendors may obtain a sales tax ID number by visiting the OTC website (https://www.ok.gov/tax) and clicking the "Online Business Registration" link (typically a five day processing time), or visiting the Oklahoma Tax Commission offices in downtown Tulsa to obtain a permit in person. The fee to the Oklahoma Tax Commission for the required sales tax ID is \$20.00.



BOOTH RULES

- Vendors must supply their own tents, tables and other booth materials.
- All vendors are required to securely tie down their tents, tables and other booth materials. Vendors are responsible for any damage caused by their booth and tent materials.
- All vendors are responsible for carrying their own product liability insurance.
- Fire safety regulations require that no portable fuel containers, oily rags or flammable trash be located in the Mercado area.

• All vendors must bring trash bags for booth clean up. Each vendor is responsible for maintaining his/her booth area in a clean, neat manner throughout the day and for cleaning his/her area before departing at the end of the day. Mercado trash cans are for customer use only.

• Produce vendors -- no cut samples are allowed unless the vendor is a licensed food handler following health department guidelines. Samples of whole pieces of fruit or vegetables are allowed.

• Each week, a limited number of booths will be designated for selling products from the back of parked vehicles. Only vehicles and trailers of one ton or smaller will be allowed in the Mercado area unless sufficient space is available for larger vehicles or unless other arrangements are made.

• Please note in the Description on your application if you need 110v electrical service. We will do our best to accommodate your request but it is not guaranteed.

VENDOR FEES

10' x 10' booth space.....\$25.00/week

Vendors must provide their own tent and tables. Kendall Whittier Main Street does **not** take a percentage of sales.
